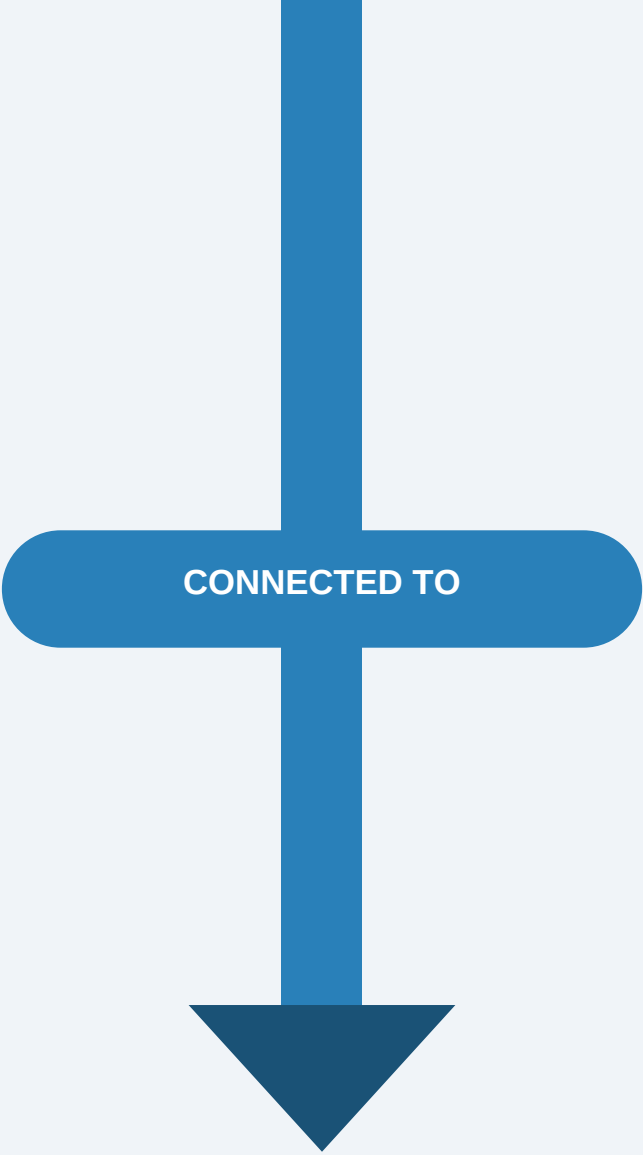

- (iii) A committee constituted at PPAC shall scrutinize all the applications basis the prescribed eligibility.
- (iv) All eligible candidates shall be called for in person interview.
