

1. In this monthly report, indigenous crude oil production, imports and processing as well as production and imports/exports of petroleum products by oil companies are analyzed to assess the domestic availability of petroleum products in the country.

Highlights


- Indigenous crude oil and condensate production during February 2020 and April 2019 –
 February 2020 was lower by 6.4% and 6% respectively as compared to the corresponding period of the previous year.
- Crude oil processed in refineries during February 2020 was 21.1 MMT, which was 5.2% higher than February 2019. On cumulative basis total crude oil processed was 233.2 MMT which was lower by 0.7% during April 2019 February 2020 as compared to the corresponding period of the previous year.
- Production of petroleum products saw a growth of 7.4% during February 2020 over February 2019. On cumulative basis production of petroleum products saw a marginal growth of 0.2% during April 2019 – February 2020 as compared to the corresponding period of the previous year.
- As the country is progressing fast on the path of implementation of BSVI standards of MS and HSD across India by 1st April 2020, production of BS VI grade of MS and HSD has increased by 28 folds and 38.5 folds respectively during February 2020 as compared to February 2019. During April 2019 February 2020 production of BS VI grade MS and HSD has increased by more than 8 folds and 16 folds respectively as compared to the corresponding period of the previous year.
- Crude oil imports increased by 9% during February 2020 as compared to February 2019.
 However, crude oil imports decreased by 0.1% during April 2019 February 2020 as compared to the corresponding period of the previous year.
- POL products imports increased by 9.6% and 32.7% during February 2020 and April 2019
 February 2020 respectively as compared to the corresponding period of the previous year. Increase in POL products imports during April 2019 -February 2020 was due to increase in imports of all products except naphtha and aviation turbine fuel (ATF).
- Exports of POL products increased by 21.4% and 7.5% during February 2020 and April 2019 February 2020 respectively as compared to the corresponding period of the previous year. Increase in POL products exports during April 2019 February 2020 was mainly due to increase in exports of naphtha and high-speed diesel (HSD).



2. Indigenous crude oil and condensate production


 The percentage share of PSU upstream companies and PSC fields in overall crude oil and condensate production during April 2019 – February 2020^(P) is shown in figure-1 below:

Figure-3; Percentage share of Indigenous/imported crude oil processed in PSU/JV refineries in April – February




Figure-4; Percentage share of Indigenous/imported crude oil processed in private refineries in April – February






Figure-5; Product wise production of POL products by refineries and fractionators: April 2019 – February 2020 (P)





Figure-6; Percentage share of POL products in production; April 2019 – February 2020^(P)









- Crude oil imports increased by 9% during February 2020 as compared to February 2019. However, crude oil imports decreased by 0.1% during April 2019 February 2020 as compared to the corresponding period of the previous year.
- Crude oil imports from OPEC countries decreased to 79.6% of total imports during April 2019 February 2020 as compared to 82.6% during April 2018 February 2019.



Import of LPG and Lubes/LOBS was done due to deficit in production and accounted for 40.3% share of total POL products import during April 2019 – February 2020 as compared to 47.1% during April 2018 – February 2019. MS (2.1 MMT) and HSD (2.6 MMT) import was done during April 2019 – February 2020 due to shutdown of refineries for implementation of BS VI projects. Import of petcoke accounted for 24.6% of total POL imports during April 2019 – February 2020. The entire quantity was imported by private importers and mainly by cement industry.




Figure 9: Percentage share of petroleum products in exports: April 2019 – February 2020 (P)
