**1.** In this monthly report, indigenous crude oil production, imports and processing as well as production and imports/exports of petroleum products by oil companies are analyzed to assess the domestic availability of petroleum products in the country.

#### Highlights

- Indigenous crude oil and condensate production during January 2021 and April January 2021 was lower by 4.6 % and 5.6 % respectively as compared to the corresponding period of the previous year.
- Crude oil processed in refineries during January 2021 was 21.8 MMT, which was 0.6 % higher than January 2020. On cumulative basis total crude oil processed was 182.2 MMT which was lower by 14.1 % during April – January 2021 as compared to April – January 2020.
- Production of petroleum products saw a de-growth of 2.5 % and 12.4 % respectively during January 2021 and April – January 2021 over the corresponding period of the previous year.
- Crude oil imports decreased by 2.7% and 13.7% during January 2021 and April-January 2021 respectively as compared to the corresponding period of the previous year.
- POL products imports decreased by 28.9% and 2.8% during January 2021 and April-January 2021 respectively as compared to the corresponding period of the previous year. Decrease in POL products imports during April-January 2021 was due to decrease in imports of high-speed diesel (HSD), motor sprit (MS), LOBS/Lube oil, naphtha and aviation turbine fuel (ATF).
- Exports of POL products decreased by 4.8% and 15% during January 2021 and April-January 2021 respectively as compared to the corresponding period of the previous year. Decrease in POL products exports during April-January 2021 (P) was due to decrease in exports of aviation turbine fuel (ATF), naphtha, motor sprit (MS), high speed diesel (HSD), fuel oil (FO), vacuum gas oil (VGO), superior kerosene oil (SKO), bitumen and liquified petroleum gas (LPG).

















Figure-5; Product wise production of POL products by refineries and fractionators: April – January 2021<sup>(P)</sup>



- Crude oil imports decreased by 2.7% and 13.7% during January 2021 and April-January 2021 respectively as compared to the corresponding period of the previous year.
- Crude oil imports from OPEC countries decreased to 75.2% of total imports during April to January 2021 as compared to 79.7% during April to January 2020.



- Imports made due to deficit in production viz. LPG and Lubes/LOBS accounted for 43.4 share of total POL products import during April-January 2021 as compared to 39.8% during April-January 2020.
- Import of petcoke accounted for 25.7% of the total POL imports during April-January 2021. The entire quantity was imported by private importers and mainly by cement industry.


